He gave his son William a bill of sale for all his personal property, the son having advanced him \$113 and he has just gone away and left everything. I do not expect him to return. We always lived happily together and I know of no cause why he should leave me in this manner.'

Several months ago he shipped considerable furniture to that place, and is supposed to have gone there and taken up his periodera.
